Dear Sir,

CRISIL has audited the Placement Report prepared by SP Jain Institute of Management and Research (SPJIMR), Mumbai, for the final placements of students in the PGPM batch of 2019. CRISIL has validated the information provided in the report with the relevant documentation, and offers the following comments:

- CRISIL has obtained all information and explanations as were necessary for conducting the audit.
 We believe the Placement Report complies with the requirements of Indian Placement Reporting
 Standards (IPRS) Version 2.2.
- The validation of information presented in the report is based on communication received by SPJIMR from the recruiting companies. CRISIL has not independently sourced any information or documentation.
- CRISIL has verified the information with respect to remuneration, job function and location presented in the report with communication received from recruiters.
 - a. Data was not available for 1 student (out of 130 students) who sought placement through the institute. We have not been able to verify the status of the 1 student in the absence of required data.
 - b. The information has been categorized as best as possible under various salary heads according to IPRS Version 2.2; where a break-up was not available, the salary has been considered only as 'Maximum earning potential'.
 - Proof of acceptance of the offers is indicated by student signing the offer letter.
 Such proof was not available for 61 students out of 129.
- 4. The number of students opting out of the placement process and students on sabbatical has been established through written communication from the students/recruiting companies.
