SPECIFIC CONDITIONS

- The institute should comply with all the conditions prescribed by the AICTE vide its letter dated 18-09-96 and a proof of this be submitted to this office for verification.
- The intake of students be restricted to 90 only and the intake should not be increased beyond approved intake under any circumstances.
- 3. Governing Council & academic Council be constituted with immediate effect.
- An endowment fund of Rs. 10 lacs be created in the joint name of the Trust and Regional
 officer, Bombay with immediate effect.
- 5. The institute may join common entrance test conducted by IIMs, IITs or any other reputed institute w.e.f. the academic year 1990-99.
- 6. Audited accounts be submitted to this office immediately. 12 and for the Alli Mi;
- 7. An expert committee of the AICTE may visit the institute to verify the conditions.
