Sir,

I am directed to convey the provisional approval of the Council to extend the period of approval of the Post Graduate Diploma programme for 1997-98 subject to fulfillment of general conditions at Annexure - I, and also the recommendations of Visiting Expert Committee report. The Specific conditions (given below) should be complied by November 30, 1997 and a proof of compliance be submitted to AICTE. An expert committee of the Council shall visit at the cost of the institute to verify the compliance of the conditions during 1997-98.

SPECIFIC CONDITIONS

1. The institute should comply with all the conditions prescribed by the AICTE vide its letter dated 18-09-96 and a proof of this be submitted to this office for verification.
2. The intake of students be restricted to 90 only and the intake should not be increased beyond approved intake under any circumstances.
3. Governing Council & academic Council be constituted with immediate effect.
4. An endowment fund of Rs. 10 lacs be created in the joint name of the Trust and Regional officer, Bombay with immediate effect.
5. The institute may join common entrance test conducted by IIMs, IITs or any other reputed institute w.e.f. the academic year 1998-99.
6. Audited accounts be submitted to this office immediately. — *det us with kind of file to take up approval of technical courses / courses*
7. An expert committee of the AICTE may visit the institute to verify the conditions.
